## Open your account faster by ensuring you have the following documents handy for your business structure.

### Sole Proprietors

- Statement of registration or Business License confirming your business name
- Current government issued photo ID
- Social Insurance Number

### Partnerships

A Partnership typically has two or more owners that will share control of the company. If your partnership includes a corporation, you'll also need to provide documents from the Corporations section.

- Partnership Agreement
- Either a Statement of Registration or a Business License confirming the business name (not required if the partnership agreement was drawn up by your lawyer)
- Current government issued photo ID for each partner
- Social Insurance Number for each partner

### Corporations

- Notice of Articles
- Documentation that shows individuals who own or control 25% or more of the business (Central Securities Register, Incorporation Agreement, Share Certificates, Record of Shareholders, etc...)
- Current government issued photo ID for each individual
- Social Insurance Number for each individual

Corporations operating for longer than a year must also bring ONE of the following current and unexpired documents:

- Latest annual report or filing receipt
- Recent tax filings (Notice of Assessment, GST/PST remittance)
- Current Business License, Liquor License or Health/Safety Certificate)

### Unincorporated Organizations

All Unincorporated Organizations need 2 individuals who are personal members of Coast Capital Savings to act as Sponsors on the account. One of the Sponsors must be a Coast Capital member with an account in good standing for a period of at least 6 months prior to opening the Organization account.

- Current government issued photo ID for each individual

Any ONE of the following to confirm the name of the organization:

- Meeting minutes
- Organizations Bylaws
- Organization's Constitution
- RA charity registration
- A letter from the governing sports association or a team roster

### Incorporated Association or Society

- Current government issued photo ID for each individual
- Constitution
- Bylaws
- Statement of Directors and Registered Office

Associations/Societies operating for longer than a year must also provide ONE of the following:

- Latest Annual Report or Filing Receipt
- Registered Charity Information Return Summary from CRA
- Recent tax filings (Notice of Assessment, GST/PST remittance)
- Current Business License, Liquor License or Health/Safety Certificates
